The standard published by CE marking is Product certification mark that indicates conformity with health, safety, and environmental protection standards for products sold within the European Economic Area (EEA). The CE marking is also found on products sold outside the EEA that are manufactured in, or designed to be sold in, the EEA. This makes the CE marking recognizable worldwide even to people who are not familiar with the European Economic Area. It is in that sense similar to the FCC Declaration of Conformity used on certain electronic devices sold in the United States.

The CE marking is the manufacturer's declaration that the product meets the requirements of the applicable EC directives.

The mark consists of the CE logo and, if applicable, the four digit identification number of the Notified Body involved in the conformity assessment procedure.

"CE" originated in 1985 as an abbreviation of Conformité Européenne (French for European Conformity), But is not defined as such in the relevant legislation. The CE marking is a symbol of free marketability in the European Economic Area (Internal Market).

b) OBJECTIVE OF THE COURSE:

The European CE certification procedure has been mainly set up to:

- 1. Harmonize all varying national regulations for consumer and industrial products in European Member States, so that the Single Market is encouraged;
- 2. Bring about cost savings for producers;
- 3. Enhance the safety of products;
- 4. Supply public bodies with a uniform procedure that can be checked.
